# Congress Agricultural Cooperative Models: Their Diversity and Sustainability in the Globalized World

### Paris 6th and 7th November 2012

With 2012 as the International Year of Cooperatives, and with a potential of 9 billion people in 2050, the UN has chosen to insist on cooperatives' positive responses to global changes.
